

SINGAPORE ACADEMY OF LAW UNDERGRADUATE SCHOLARSHIP

TERMS AND CONDITIONS

- The Singapore Academy of Law (SAL) Undergraduate Scholarship is open to new law students who are eligible for government tuition grant in the Bachelor of Laws and Juris Doctor programmes.
- 2. Applicants must be Singapore Citizens with good academic and co-curricular activities records, active participation in community service and possess strong language skills.
- 3. Applicants should have a monthly household Per Capita Income (PCI) of S\$4,300 or lower.
- 4. The scholarship award will cover 100% of the tuition fees (including tuition grant) plus living allowance of \$10,000 per year that the student is supported for under the award.
- 5. The scholarship recipient(s) may be offered opportunities to meet and interact with leading practitioners and contribute to key developments by participating in SAL activities and internships or in SAL's working committees chaired by esteemed members of the Singapore Judiciary.
- 6. Prospective students must separately submit the online Admission Application to SUSS and must be accepted for admission before being awarded the scholarship.
- 7. Scholarship recipients are not required to serve a bond with the University. They may not concurrently hold any other form of free aid such as bursaries, scholarships or grants, without prior written approval from the University and the SAL.
- 8. Recipients are required to sit for all examinations, complete the programme within the prescribed time and conform to regulations, instructions and discipline in force for the respective programme. In addition, scholars must have good conduct and maintain their academic performance as the top 50% of the cohort in each Academic Year.
- 9. Scholars must continue to demonstrate financial needs throughout the period of studies in each Academic Year.
- 10. Scholars will be required to take part in university's activities/events, and community involvement projects as deemed appropriate and/or directed by the University.
- 11. Applicants are required to submit copies of educational certificates, transcripts, pay slip and other supporting documents together with the scholarship application. Otherwise, the application would be considered as incomplete and will not be processed.
- 12. Scholarship application must be submitted online **by 15 September** and recipients are not allowed to request for deferment of the award.



- 13. Shortlisted candidates will be notified by SAL to attend an interview <u>by mid-November</u>. The decision of the University and SAL on the selection of scholarship candidates is final and no appeal will be entertained.
- 14. The University reserves the right to withdraw or suspend the scholarship at any time if, in its opinion, the recipient's conduct and/or academic performance has not been satisfactory.
- 15. The University reserves the right to amend the above terms and conditions at its sole discretion without prior notice.

A separate letter and agreement with the detailed terms and conditions (including the above terms and conditions) and others relating to the course of study will be given to all successful scholarship candidates.
