

Ways of giving



Charitable Bequest

Include SUSS in Your Will

Anyone – regardless of financial status – can make a charitable bequest, as it will only be in effect after this lifetime.

A charitable bequest can take many forms. You can leave a specific asset, a sum of money, a percentage of your estate, or what remains of your estate after you have provided for your family and other causes. Engage a legal advisor, or make use of a will writing service to draw up your will. You remain in complete control of the process and you can change any bequest provision anytime during your lifetime.



Central Provident Fund Nomination

Include SUSS as a Beneficiary

Your Central Provident Fund (CPF) savings are excluded from your will. Nominate SUSS as a beneficiary of your CPF savings, which include monies in your accounts, as well as CPF Life premiums and stocks and shares bought using your CPF savings, on your CPF Nomination Form. When the time comes, your CPF savings will be distributed in line with the nomination you made.

Name SUSS as the Beneficiary
